1.	At page 3 of 5 of Supply contract notice you predicted that, for all 4 lots, selection criteria are:  Economic and financial capacity - the average annual turnover of the tenderer must exceed the value of the Tenderer's Financial proposal.  Professional capacity - has a professional certificate appropriate to this contract, such as certificate ensuring conformity to and ISO 9001 quality management system.  - at least 2 staff currently work for the tenderer in fields related to this contract  Technical capacity - the tenderer has delivered supplies under at least 2 contracts with a budget of at least value Tenderers financial proposal regarding municipal waste	Tenderers are asked to submit document D Tender form for a supply contract, where they indicate their economic and financial capacity, professional capacity and technical capacity. Supporting documents are not asked to be provided to Contracting Authority in tendering phase, but it might happen in contracting phase of this procurement. All supporting documents for this tender must be in official language of the tender – English language or in the language of the country where the Contracting Authority is registered, in this case Serbian language. All documents issued in any other language should be translated into official language of the tender.

QUESTION: Which documents tenderers have to attach to prove their economic and financial capacity, professional capacity and technical capacity? Please clarify. Also, please clarify if documents – evidence of tenderer's capacity, as well as documents you predicted in Declaration on honour on exclusion criteria and selection criteria, must be translated on English or not?	
2.	At page3 of 5 of Supply contract notice, for technical capacity of tenderer, reference period is 5 years, but at document c4l - TENDER FORM FOR A SUPPLY CONTRACT, table 6 - Experience - required - is major relevant supplies carried out over the past 3 years.  QUESTION: Please clarify. What is reference period for experience 5 or 3 years?	Reference period for experience is 5 years. The document D Tender form for a supply contract, in chapter 6 has been corrected.
3.	If tenderer submits a bid for more than one lot, is he fill in	Tenderer has to provide offers separately for each lot.

	Annex IV: Budget breakdown (Model financial offer) separate for each lot or one table for all lots together with total price (summary for all lots he offer)?  QUESTION: Please clarify. What is reference period for experience 5 or 3 years?	Reference period for experience is 5 years.
4.	In lot 1 "Supply of waste collection vehicle" you required superstructure with following characteristic: "Separate mechanism for discharging of containers of volume from 5m3 to 7m3, made according to standard EN 840-1,2,3" From years of experience as a producer of waste collection superstructures, we consider that experience with such a demanding and specific superstructure as you required is very important for tenderer.  On the other hand, you predicted as technical capacity at least 2 contracts regarding municipal waste management or similar.  We suggest you to change this requirement regarding technical capacity and require implemented contract for specific superstructures as required in this tender, not just contract regarding municipal management or similar.	In order to allow wider participation of possible tenderers, Contracting Authority defined technical capacity requirement to be related to municipal waste management or similar. The contracts related to specific superstructure as required in this tender are considered in line with defined criteria municipal waste management or similar.
